<b>Control Measures</b>
<p><b>Provide details of the control measures you will implement to mitigate the risk</b></p> <p><b>Training-</b></p> <p><b>A return to work briefing has been carried out with all staff- following HSE Published Guidance, along with a comprehensive Covid -19 online training module, this covered detail of social distancing and the importance of hand washing and contact point sanitising. All staff are aware of symptoms associated with the virus and must not attend work if they develop any of the symptoms, all managers are also aware to send any staff who become unwell home immediately on shift, in line with current government advice.</b></p> <p><b>The online module also covered- personal protection/staying safe/looking after customers/preparing to reopen/ service standards with covid in mind.</b></p> <p><b>Physical Distancing-</b></p> <p><b>Jute Café Bar operates with a 1 metre plus rule in line with current advice, this applies to all staff, customers, delivery staff and other visitors</b></p>

**Where possible staff will be allocated to 1 table for service**

**Furniture has been reallocated to allow for more space between tables**

**Servers must remain 1 metre where possible when taking orders and dealing with customer requests**

**There is no service available at the bar counter**

**There is no vertical drinking permitted, customers must have a table**

**All visitors must leave their contact details for test and track**

**All visitors temperatures are checked on arrival**

**Floor signage has been added to assist with your visit throughout the building**

**Where possible we will prevent queues and advise using our online booking system to reserve a table ahead of your visit to assist with a speedy arrival to Jute.**

**Staff breaks have been staggered to ensure that they are not mixing unnecessarily**

**We will also have a full record of staff rotas to ensure we have the necessary details for test and trace**

**In line with current guidance we are not playing any background music**

**Face covering must be work by all staff all the time and by all visitors when not seated at a table.**

**Kitchen and Back of House Areas-**

**Kitchen access is restricted to prevent mixing of different departments**

**Spacing has been put in place within the working areas**

**Additional cleaning/sanitising and control measures are all in place**

**Hand washing-**

**Hand washing facilities for staff are in place and staff are aware of the importance of regular hand washing, signage has been placed throughout, alcohol sanitiser stations are located throughout Jute and are available for both staff and visitors.**

**Cleaning-**

**More frequent cleaning regimes have been implemented including all contact points, tables and chairs after every use with an appropriate detergent.**

**Disposable paper towels will be used wherever possible**

**Where possible all commodities required by customers will be single use, sugars, salt and pepper, sauces etc**

**All menus will be single use so we will be only giving 1 menu to each table.**
